- les AD qui concernent les avions de masse maximale au décollage inférieure ou égale à 2000 kg, les planeurs, les motoplaneurs et/ou les aérostats pour lesquels la publication est toujours accompagnée d'une traduction de courtoisie.

Le site EASA reste le site de référence pour la diffusion des CN/AD. La reprise des CN/AD sur le site OSAC ne constitue qu'un rappel, et tout délai de mise à jour du site OSAC ne pourrait justifier une non-application de la CN/AD dans les délais prescrits.

Since 1 September 2025, and as announced in Information Bulletin BI 2025-06 (available on the OSAC website), CN/ADs issued by EASA or any foreign design authority, applicable to aircraft subject to European regulations and registered in the French register, are no longer published on the OSAC website except for:

- *Emergency ADs, and*
- *ADs concerning aeroplanes with a maximum take-off mass of 2,000 kg or less, gliders, motor gliders and/or aerostats, for which the publication is always accompanied by a courtesy translation.*

The EASA website remains the reference site for the release of CN/ADs. The inclusion of CN/ADs on the OSAC website is for reference purposes only, and any delay in updating the OSAC website cannot justify non-application of the CN/AD within the prescribed time limits.
